



On Human Rights Day, We Rise Together Against Torture

As we mark Human Rights Day, the United Against Torture Consortium by [Association for the Prevention of Torture \(APT\)](#), the [International Rehabilitation Council for Torture Victims \(IRCT\)](#), the [International Federation of Action by Christians for the Abolition of Torture \(FIACAT\)](#), [REDRESS](#), the [Omega Research Foundation](#), and the [World Organisation Against Torture \(OMCT\)](#) reflects on a year of collective resolve and impact. Since 2023, the consortium has supported more than 12,000 survivors, advanced landmark legal and policy reforms, strengthened hundreds of civil society organisations, and mobilised millions through global advocacy. From historic ratifications of the Optional Protocol to the Convention against Torture (OPCAT) to rapid crisis responses and survivor-led initiatives shaping UN agendas, our movement continues to defend dignity and push for accountability worldwide. Together, we remain steadfast in building a world free from torture — a commitment we renew as we close out 2025 and look ahead to the work still to come.

OUR IMPACT



Support to survivors: Over **12,000** survivors of torture received legal, medical, and psychosocial assistance.



Global advocacy impact: Over **2 million people** were reached through campaigns and survivor testimonies, including regional and youth-led initiatives.



Global advocacy success: UATC's efforts as part of the Torture-Free Trade Network led to the revision of the EU anti-torture regulation.



Strengthening civil society: **227** anti-torture **CSOs** in **55** countries received funding and **227** engaged directly with the UN Committee against Torture.



Legal and policy wins: We achieved **29** legal victories securing accountability and justice for victims in **19 countries**; **59** initiatives advanced National Preventive Mechanisms (NPMs).



Rapid crisis response: We launched timely interventions in response to urgent torture situations in **Bangladesh, Palestine and the DRC**.



Voices of survivors at the heart of UN work: We held **regional hearings of survivors** in Africa, Asia and Latin America, informing an upcoming thematic report of the UN Special Rapporteur on torture on experiences and perspectives of victims and survivors of torture and other ill-treatment.



Historic policy win in Colombia: After years of coordinated efforts with local partners and a survivor-led movement, **Colombia ratified the Optional Protocol to the Convention Against Torture** (OPCAT) on 10 November 2025.



Movement building: Over **40 human rights defenders** from Africa gathered in Banjul for two days of strategic discussions, knowledge sharing, and solidarity.

Advancing Torture Prevention in Bangladesh

On 17 July 2025, Bangladesh acceded to OPCAT, and the Convention against Torture itself entered into force a month later. This historic step marks a milestone in the country's human rights journey and signals a strong commitment to dignity, accountability, and justice.

This new FIACAT policy brief shows how criminalising petty offences caused unnecessary arrests and prison overcrowding. It also urges States to adopt human rights-based reforms.

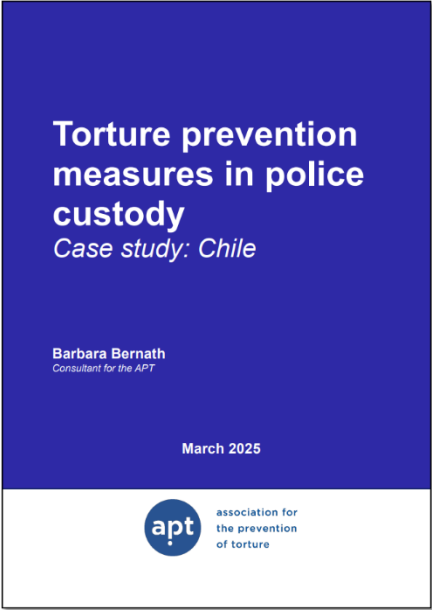
